The additional 8 hours of training required by Sections 75 (g) and (i) of the Act will be comprised of components #4 and #5. The individual hourly break down for the required blocks of instruction are recommendations based on the training of a firearms novice. Instructors may tailor their curriculum as needed, provided the listed minimum requirements are delivered.

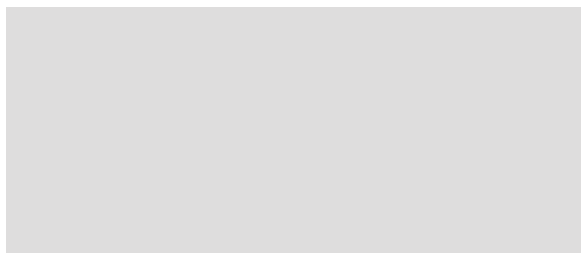
